### BUS FARE

- On a daily basis, campers will ride the LTD buses to explore various fun and learning opportunities in our community. **A pre-purchased bus pass (by parents/guardian of Camper) or a weekly bus fare (paid at registration) is required for your Camper to attend the camp.**
  - If your Camper attends multiple weeks of camps, bus pass may be cheaper! Monthly Bus Passes (\$25) and Summer Fun Bus Passes (approximately \$50 for May 28, 2018 – September 3, 2018) are available at LTD.
- I will have pre-purchased bus pass before the Camper's first day of camp and the Camper will bring the bus pass every day to attend the camp.
- I have included weekly bus fare with this registration.

### CANCELLATION POLICY

- For cancellation at least 14 days before the first day of the registered camp, 80% of the fee will be refunded.
- Cancellation at least 3 days before the first day of the registered camp (i.e., before the Friday immediately prior to the first day of the registered camp), 50% of the fee will be refunded.
- Any cancellation within 3 days before the first day of the registered camp (including the Friday immediately prior to the first day of the registered camp) will not receive a refund.

### EXPECTATIONS FOR CAMPERS

- Follow instructions of camp instructors and always stay with your group.

If these behavior expectations are not followed, there will be consequences. In the rare event that a Camper's behavior requires disciplinary action, the following steps will be used:

- Camp instructor will discuss the problem with the Camper to reach a solution.
- Camp instructor will call and inform the parent/guardian of the behavior and to discuss possible solutions. An agreement among the parent, Camper and instructor will be reached and enforced.
- If the Camper continues to display disruptive behavior in the camp, the Camper will be permanently dismissed from the camp and no refund will be issued.
