A pre-purchased bus pass (by parents/guardian of Camper) or a weekly bus fare (paid at registration) is required for your Camper to attend the camp.</li> <li>If your Camper attends multiple weeks of camps, bus pass may be cheaper! Monthly Bus Passes (\$25) and Summer Fun Bus Passes (approximately \$50 for May 28, 2018 – September 3, 2018) are available at LTD.</li> </ul>

CANCELLATION POLICY
<ul> <li>For cancellation at least 14 days before the first day of the registered camp, 80% of the fee will be refunded.</li> <li>Cancellation at least 3 days before the first day of the registered camp (i.e., before the Friday immediately prior to the first day of the registered camp), 50% of the fee will be refunded.</li> <li>Any cancellation within 3 days before the first day of the registered camp (including the Friday immediately prior to the first day of the registered camp) will not receive a refund.</li> </ul>

EXPECTATIONS FOR CAMPERS
<ul> <li>Arrive at camp ready to learn and have fun.</li> <li>Show respect for yourself and others. Engaging in activities or behavior that could hurt others' feelings or person is not acceptable.</li> <li>Follow instructions of camp instructors and always stay with your group.</li> <li>If these behavior expectations are not followed, there will be consequences. In the rare event that a Camper's behavior requires disciplinary action, the following steps will be used:</li> </ul>
<ul> <li>Camp instructor will discuss the problem with the Camper to reach a solution.</li> <li>Camp instructor will call and inform the parent/guardian of the behavior and to discuss possible solutions. An agreement among the parent, Camper and instructor will be reached and enforced.</li> <li>If the Camper continues to display disruptive behavior in the camp, the Camper will be permanently dismissed from the camp and no refund will be issued.</li> </ul>
